Hello my name is Andrew and I am an alcoholic.

I started drinking when I was in high school. I would drink until I would pass out or black out. I would ask my friends what I did and they would get upset with me. It got to the point where I stopped asking and just enjoyed my drinking. I figured that if I didn't remember my bad behavior; I couldn't be held accountable for it.

My wife would say things that most of us hear, like stop drinking so much, or not so much tonight. My justifications ranged from I only had a couple to I'm ok just leave me alone. Until finally, I issued the Alcoholic's Ultimatum I drank before you met me and I

will always drink if you don't like it then you can just leave. I continued to drink for a few more years. I didn't even put the beer in the fridge anymore

"God please help me, I can't stop on my own and I don't know what to do anymore."

because it was too far to walk.

One morning while sitting on the floor with empty beer cans

around me I prayed: "God, please help me, I cant stop on my own and I don't know what to do anymore." It wasn't long after that my prayer was answered and I went into my rehab: County jail.

That is where I was able to get sober. When I got out, A.A. was there and thank God for that. If not for the grace of God I would not be here today. I can look back on that experience and see how I was so powerless over alcohol, and how unmanageable my life had become.

Sadie said, "we all have only so much free time (time spent not working on ourselves)." she neither remembered me, nor the truthful remark. That's okay, she went forth everywhere with me as one of my rocks on the program. We don't get to know when we help somebody.
