The long timer's panel and my spiritual experience.

I recently attended a panel meeting at an Alano club in the high desert. I wanted to share my experience of what it was like what happened and what it is like now.

I know what's said here stays here, who we see here, and so on. So out of respect for our traditions, I won't mention any names or locations. I've only been in the high desert four years and I have attended a number of meetings at different locations.

I heard of this meeting through a friend and my only experience in panels was from H & I. I had never heard of a panel such as this. My sponsor taught me to always try to keep an open mind, so I thought I would go check it out. Man was I happy I did. There were five guys on the panel. They're combined years of sobriety, totaled over 200 years. It was a Q&A panel where we got to write down questions and ask them their experience and there were some great questions asked: we got to hear what it was like, way back when.

The guys that were there had immense experience obviously. I've been to question-and-answer meetings, where the question most asked is, "they say don't get in a relationship for the first year". This was nothing like that. We got to hear a little bit about Akron a little bit about LA, a little bit about Colorado, and even the High Desert.

I felt like I was brand-new again, listening to every word, waiting to hear the secret but their answer was the same today as it was yesterday as it will be tomorrow. Chapter 7 was the secret. As I sat and listened to the questions and each of the members share their experience, I felt the presence of God in that room as I have on several occasions in various meetings. They seem somewhat different as it was. I was not only gaining experience. I was being given strength and hope that if I continued to do what I'd been doing for a couple of days now. I might have the privilege of sticking around a couple more days.

An Open Letter to the Dually-Addicted

Well, I never thought that I would be typing a letter about the salvation of ALCOHOLICS ANONYMOUS as we know it, but I can't sit back any longer and let what I deem is the beginning of the end of A.A. go unnoticed. It is because of people who are double addicted that want to share in A.A. meetings about past drug addictions. The comments from them are that they should be able to share about drugs and the reason they come to A.A. is because it is a better program than N.A. "What's the matter with that?" they holler, "Alcohol is a drug, too!" True, but this is Alcoholics Anonymous. If they want to share about both, they should start a whole new program that covers both. They can call it N.A./A.A., go on their own, and leave A.A. alone. They can print their own literature, make a separate Central Office, do their own thing, and tell the drug counselors and the drug courts to send the dually-addicted to their program. Bill W. said if A.A. fails it will fail from within and he may be right if we let this kind of attitude in our fellowship. I don't think we need that. We are doing fine without the attitude and the drug stories.

I went to an A.A. meeting where they count down years of sobriety. At the end of the meeting, they gave the total number of years from the count down. On this particular night, there was a little more than 200 years sobriety in a meeting of over 60 people. The comment by the countdown person was "Where are the long timers?" Stop and read the first paragraph of this letter again. The long timers want to go to A.A. meetings with a singleness of purpose of one alcoholic helping another alcoholic. I talked to an old timer who said he was at an A.A. meeting with eleven others and between them they had 363 years. Where do you think they are? A dual attitude is driving them away from meetings! Dual addiction ATTITUDES allowed to be shared in a **REGISTERED A.A. MEETING OF** ALCOHOLICS ANONYMOUS is a violation of A.A.'s singleness of purpose. It's about time that any A.A. meeting that lets this dual addiction attitude prevail, be dropped from the Registry in New York and taken out of the local directory. Time has come to get on board to the better way "A.A." Don't let anyone or anything put us down! Stand together on what the fellowship is based on — "The Original Twelve Steps" and "The Original Twelve Traditions!"

PROBLEMS OTHER THAN ALCOHOL (excerpts)

The following excerpts from a grapevine article by A.A.'s co founder Bill W. represents principals which have been reaffirmed by the members of the A.A. General Service Conference of 1969, 1970, and 1972.

"The problem of drug addiction in its several forms lies close to us all. It stirs our deepest interest and sympathy. Many A.A.'s especially those who have suffered these particular addictions, are now asking, what can we do about drugs—within our fellowship, and without?"

"Specifically, here is a list of questions we are often asked:"

- 1. Can a nonalcoholic pill or drug addict become an A.A. member? NO
- Can such a person be brought, as a visitor, to an open meeting for help and inspiration? YES
- 3. If so, should these nonalcoholic pill or drug users be led to believe that they have become A.A. members? NO
- 4. Can a pill or drug taker, who also has a genuine alcoholic history, become a A.A. member? YES

"Now there are certain things that A.A. cannot do for anybody, regardless of what our desires or sympathies may be. Our first duty, as a fellowship, is to ensure our own survival. Therefore, we have to avoid distractions and multipurpose activity.

Sobriety—freedom from alcohol– through the teaching and practice of the Twelve Steps, is the

sole purpose of an A.A. group. Groups have repeatedly tried other activities, and they have always failed. It has also been learned that there is no possible way to make nonalcoholic into A.A. members. We have to confine our membership to alcoholics, and we have to confine our A.A. group to a single purpose. If we don't stick to these principles, we shall almost surely collapse. And if we collapse, we cannot help anyone.

I see no way of making addicts into A.A. members. Experience says loudly that we can admit no exceptions, even though drug users and alcoholics happen to be first cousins of a sort. If we persist in trying this, I'm afraid it will be hard on the drug user himself, as well as on A.A. We must accept the fact that no nonalcoholic, whatever his affliction, can be converted into an alcoholic ... and an A.A. member.

We cannot give A.A. membership to nonalcoholic addicts. But, like anyone else, they should be able to attend open A.A. meetings, provided, of course, that the group themselves are willing."
